Weathering and Painting Clinic Ed Enyedy presents March clinic

Ed Enyedy shared his painting/weathering skills during the March clinic. Enyedy used samples of his 3D printed <u>Leopard Architectural Models</u> to demonstrate his techniques using acrylic paints, paint sticks, and even hairspray.

At the conclusion of the clinic Enyedy donated numerous painted and weathered structures to Division 1. The items will be raffled off at the April meeting.

Add Some Interest to Your Layout

Detailing and palletizing 55 gallon drums

What an exciting title! Not really, but it is a fun quick way to dress up your layout.

Before I get started let's have a short discussion on rules. (probably the real reason for this article) You will hear me refer to "the three foot rule." OPS guys know a lot about rules - for some reason they think it's part of the "fun." After a nearly forty year career in the military I've come across my share of "rules." You can see this is getting off of the "Detailing & Palletizing 55 Gallon Drums." It's an opportunity to



poke some fun, and that's what our hobby is supposed to be about, right?

The three foot rule is defined as: The distance that most of us view a model. The three foot part is really variable depending on your level of infirmity. The distance may be increased or decreased as needed.

What you will need:

- some 55 gallon drums. The number is up to you. The more you do the better they'll look in a group at the end. This also gives you a place to hide an oops in back and nobody will see it - see three foot rule.
- a sharp hobby knife new blade for best results or a pair of sharp scissors.
- gloss paint color of your choice. I like Rust-Oleum Bright Coat Metallic Finish in silver.
- optional but strongly suggested get a bottle of Microscale Liquid Decal Film. This is great stuff. Often older decals become brittle and when you put them in water they explode. Ask me how I know this... This stuff avoids that and makes them like new. Easy to use, just brush some on.
- decals The most important part! Since I don't know of any decal sets for 55 gallon drums you have to get creative. Every train show has

someone selling old decals (Don't forget the Liquid Decal Film) One good source is N scale decals. This stuff is already to small for most humans to read. See the three foot rule. You're not necessarily looking for readability. The idea is there's something there and it draws your attention. HO scale truck and trailer sets, shipping containers, locomotive data, reporting marks (series of four letters). Again most of this stuff is too small to read. Lastly most of us have an envelope of long forgotten decals somewhere in our stuff, get it out and look it over in a different light.

- pallets - use a decent pallet to mount your new masterpiece on. There are many available. The most realistic and affordable I've found is a new release by "Leaving A Mark Engraving." He's a local guy that's very easy to work with.

The nuts and bolts part of this project is very simple. Paint, decal, glue it on a pallet - we've all done it, no need to go in the fine details - it's not rocket science. Don't complicate it.

Note for N scalers: your stuff is already way to small for most humans to see so I don't know what to tell you. Try your best and invoke the three foot rule! It should work.

Module Group Report MCR Convention to host both HO and N Scale T-TRAK

The Division 1 HO T-TRAK layout will be set up at the Mid-Central Regional Convention May 16 - 18, 2024, held at the Crown Plaza Hotel in Middleburg Heights, OH. An N scale T-TRAK layout will also be on display. If you want your N scale module(s) in the convention, they must be registered on the <u>MCR Convention website</u>. For the HO layout we will need to furnish our own tables.

Please make note of the following information for both the HO and N scale set up and tear down times:

Set up will be Thursday, May 16, at 11 AM. Teardown will be Saturday, May 18, starting around 2 PM.

- All T-TRAK layouts need to be removed by 4 PM on Saturday due to the room needing to be set up for the convention banquet. I will be contacting train show promoters for the fall. If you know of an event or place that could be a possibility, contact them and ask if they would consider us. With a positive response, share their contact info with me, and mine with them. The N scale layout is perfect for small events needing only two tables pushed together.

I have two other items to discuss. The first is the Divisions corner modules, tables, and Rolling Command Stations. In my situation, once I have the RCS fully debugged and all the cables made, and the two corner sections complete where will they be stored? My space is limited plus I am on the most western part of the Division. I think they should be in a more central location of where most of the members are located. I think the T-TRAK Committee, should come up with two options, present them to the members, and let the members decide.

The Second item is an Assistant Module Chair to replace Don Bonk. With Division 1 having two functioning layouts to display an assistant is needed. They can help with finding venues and being in charge of the setup, etc. If no one volunteers, I have a couple people in mind to ask to volunteer.
