Superintendents Message

We have been lucky in the past to have many individuals hosting our meetings. He also reminded me that for many of us (including me), building a layout is a solitary job. Most of us DO build our layout by ourselves. I know of only a few who have built personal layouts with a lot of helpers, but they are few and far between. To this end, the officers of the Division are working to get more people to offer clinics. We have had several good clinics this past year.

Starting a flea market is a good socialization tool. Bob Ashley, Jr. is primarily responsible for starting the flea market. He also has secured the Akron Yacht Club as a location for this year's event.

The module group is also a good tool. Bob Ashley, Sr. is responsible for the group. His idea and his leadership of the group have brought us contact with Division 4 and 5. This group is currently small, but we do hope it will grow.

For more than two years I have invited any interested person to operate on my layout. Lately, those invitations have stopped. They will resume in the Fall. This is a good way to get to know other people. It is a good way to get a start in operations. *There is much that you can do in Division 1. All you need to do it take advantage of what is offered.*

DIVISION 1 CHANGES

Certain actions must taken to insure that Division 1 is eligible and continues to be eligible for the NMRA provided liability insurance. These actions are not being taken lightly. Were anything to happen to trigger the need for liability insurance and Division 1 was found to have non-NMRA members involved with the Division, the insurance would be negated and the elected officers of Division 1 would be personally liable. That is a position that I do not wish to find myself, the other officers or any future officers.

Requirements for the \$1,000,000 liability insurance provided by NMRA have brought about the need for a few changes. Since we are having meetings in various homes and planning a Flea Market, we need to be absolutely sure that our membership is without a doubt 100% NMRA. Two problems have shown up.

The first problem concerns the Peddler Freight. The Division currently sells Peddler Freight subscriptions to non-NMRA members. As of now we will no longer sell subscriptions to the Peddler Freight to non-NMRA members. (All current subscriptions end with the June issue.)

The second concerns non-NMRA visitors (other than spouses and families). Non-NMRA visitors are welcome to come to a meeting or two. They will be given NMRA membership information and a membership application. This will be done twice before they are asked to join or stop attending.

These two actions will leave no question about our membership and no question about insurance, should it be needed.

These are based on the insurance requirements and the fact that Division 1 is a basic part of the NMRA. We are NOT an independent club. We are the local Division of the NMRA and shall be operated accordingly.

Subscribers have been helping to pay for those who do not subscribe. That is greatly appreciated. However, costs are *not* always fully covered.

Friday October 16 to Sunday October 18, 2009

Enjoy the fall colors and a ride behind the Shay locomotives to Bald Knob, railway museum and other items of interest at Cass, West Virginia.

We will be traveling to Cass by tour bus and will have a special car on the train for our group. Two meals will be included on Saturday. We will be staying at the Econo Lodge in Beckley, West Virginia on Friday and Saturday nights.

Cost: \$160.00 which includes the bus transportation, railcar, train ticket, box lunch and supper at the Last Run Restaurant in Cass.

Not Included: Hotel, Friday dinner and Sunday lunch and souvenirs. There are restaurants within walking distance of the Econo Lodge.

Continental breakfast will be served at the Econo Lodge Saturday and Sunday mornings. Each person or group which will be staying together will have to make their own reservations with Econo Lodge. We have a group rate of \$99.99 plus tax for each room. Call Econo Lodge to make your reservations at 1-888-259-8542. You must ask for the Mid Central Region NMRA, Division 4 to get the group rate. We have 25 rooms available and reservations must be made by August 15, 2009.

The box lunch will consist of a lunch meat sandwich, chips, fruit, drink and desert. Saturday supper will be a buffet style meal with two entrees, vegetable, baked potato, salad, desert and drink.

We will leave from the Quality Inn in Richfield Friday afternoon at 1:00 PM and return Sunday about the same time. Parking will be available for the weekend.

The \$160.00 will be due as follows: \$100.00 by July 1, 2009 and the balance by September 11, 2009 (at the regular Division meeting for September).

<u>Cancellation Policy</u>: Current Division 4 cancellation policy will apply. Policy will be given to participants when they pay the initial deposit.

The costs for the trip are based on a breakeven number of 30 participants. The Bus Capacity is 50. If we have over 30 participants excess money will be refunded on a pro rata basis to each participant.
