# Module Group

The next scheduled event will be the Youngstown Model Railroad Association Flea Market at Salem, OH, Sunday, January 14, 2018, at the CenterPlex Community Center, 1098 North Ellsworth Ave. This event will repeat on April 8, 2018. As before, we will setup at 1:00 pm, on Saturday, January 13. The HO modules, only, will be operated. **Everyone should help operate the modules regardless of the scale you model.** Please mark your calendars and be sure to come help us setup and operate the modules.

We are pleased to announce that Jon Ulbright has secured a very large building in Mt. Hope, about 10 miles south of Dalton and near Berlin in Wayne county. He has two shows scheduled for Saturday, March 24 and Saturday, November 3, 2018. This building will allow for more than 600 tables and give us more room for the modules. There will be more on these events next month.

I am nearly finished with my expansion module that will extend the length of the Mack Industries Cement plant and the Mack Concrete facility by four feet. This will allow more room for the FracTech Sand operation.

Bob Ashley, Jr. is still working on a design for an outside curve, which is reversible, so it can be used as an inside curve. Once this design is complete, we will try to have two made before the Mt. Hope show. We will advise by email if we can get a work party to do that.

Bob Brock, from Division 2, Pittsburgh, purchased a module kit so he can experiment with an interface for Free-mo modules. He would like to be able to adapt their Free-mo modules to our NMRA standard modules. It will be necessary to lower their modules 10" so they can hook-up to our layout and operate from our controls. He and I are both experienced with CAD drafting and will be designing something to do this. He will pick up his module kit at the Salem show.

**Those of you who want a module; you need to contact me so I can order electrical components and more lumber. See my email and phone numbers below.** We will schedule a date to build the module(s). The final price will be around \$110.00 for the kit. Those who build a 4' x 2' module with scenery, which is eight square feet minimum, can apply for the "Golden Spike" and other AP awards.

We are always looking for venues where we can display and operate our modules. We can be an added attraction for many events, i.e., Railroad Days, shows at event centers, library historical programs, student events, etc. Please call me or any Module Group member if you think you have a lead and make sure the event coordinator is aware of your concern

**Those of you who use AAA or AA batteries in your NCE throttles or any other devices need to be aware that these batteries can short on the (-) minus end if the plastic shrink wrap, around the battery, splits allowing the (-) minus contact to bridge the end of the battery with the outside of the battery. The outside of the battery is (+) positive for the entire length of the battery with the (+) positive end. The contact in the NCE throttles is very wide allowing this to happen. Enough heat can be generated to melt the battery enclosure and cause severe burns to your hand. The only way to stop the short is to remove the batteries immediately. Never touch the batteries, if this happens, to avoid severe burns. If anyone else has experienced this, please let me know. All battery brands that I have tested have this type of construction to minimize leaks. NCE will be notified of this incident.** Read below and see a video about what can happen with a 9v battery, similar to those used in Digitrax throttles.

- II. **Treasurer's Report:** The report was given by Treasurer Mike Bradley. One N-scale ACY car 2-pack was sold by Bruce Hukill at the Trainfest in Milwaukee. A motion was made and seconded to accept the October 2017 Treasurer's report subject to audit. The motion passed. Mike stated that a new checking account had been opened for the 2019 regional convention.
- III. **Minutes:** A motion was made to accept the minutes for the corrected October 2017 meeting as they appeared in the Peddler Freight. The motion was seconded and passed.
- IV. **Membership:** Larry Brown was absent so there was no report.
- V. **Committee Reports:**

# N-SCALE REPORT

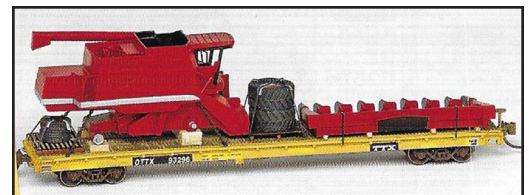
I believe two reasons that younger generations don't model trains is; they don't see them as often and the trains they do see have no class. The trains of today are too utilitarian unless they have been tagged with graffiti. By freelance modeling 1938 through 1954 I get to model trains with great logos and graphics.

The following are some of the releases by manufacturers now and in the future.

This is a Special Run N Scale Enthusiast which has a lot of Class. If I read the build date correctly it is 6-13 and car may have operated for thirty plus years after the build date or to 1964.



These Combine models by GHQ have been on the market for some time and may be available on ebay. (Editor's note: A GHQ 'green 9500 wheat combine kit' was recently listed on ebay.)



This is one of the Friendship Cars from a series by Micro-Trains. A Rice Car from Arkansas was previously shown for Bring and Brag at a Division meeting. This car was one of 250 cars which were put together by local groups across the USA to aid France and Italy after WWII. This appears to be a 12 Car series 059 00 ---.



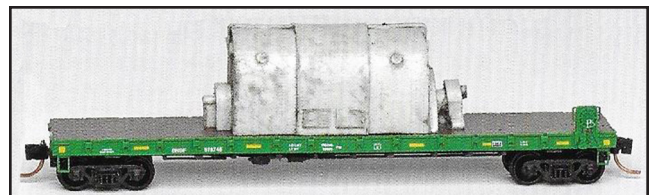
This is Car #1 of Micro-Trains Heinz 36' wood sheathed reefers. Again this is a 12 car set which was released in August. Series 058 00 ---.

1. The meeting was called to order at 1:30 PM
2. Opening reports/updates
  - a. Bruce gave each attendee a sample AC&Y rail pass that could be used on IDs on the neck lanyards. He will start on a short version of the registration form and he has completed the pre-registration form. The completed forms will be sent to Randy. Bruce has started on the tri-fold handout based on the 2017 Louisville convention form. Our prices have been set and the dates can be set based on what Cincinnati is using for their convention.
  - b. Jim Williams reported that the shirt prices would be the same as the division shirts. Each shirt will have the logo and the person's name. EmbroidMe is working on a price for the Bullet logo. The round part of the logo should be the size of the division logo. We will have people pre-pay for shirts when they order them.
  - c. Jim DiPaola and Mike are still researching the source and cost of pens and pins.
  - d. Gary reported that he has not heard back from the printer he uses. The printer needs to be provided a high-resolution (300 pixels or greater) PDF for anything we need printed. He also stressed that we needed to be explicit with the vendors that this is not a flea market. We also need a vendor registration form.
  - e. Steve reported that we want to have an independent website off our division website and one that other divisions in the Mid-Central region can attach to. He is still working on how to do this.
  - f. Several non-rail activities were discussed: the Butler Museum in Youngstown, shopping in Grove City, PA(day trip), the casino in Austintown. The Louisville convention had a rail and non-rail tour each on Friday and Saturday.
  - g. Bruce asked if we wanted to suggest sites for prototype rail-fanning. He will ask Josh to suggest some sites in the Youngstown area.
  - h. Mike reported that the checking account is setup and he has started the credit card application. We need to post our tax-exemption document in Dropbox (Randy will send it to Steve) and make all the vendors we use aware of our status.
  - i. Steve and Jim DiPaola will publish a timetable in Dropbox for the requirements for the Cincinnati convention in May, 2018.
  - j. Jim DiPaola is in charge of putting together the large tri-fold to be used in Cincinnati to advertise our convention in 2019. It will essentially have the same information as the paper, handout tri-fold that Bruce is creating.
  - k. Jim Peters is in charge of layout tours and OP sessions. He will report the next meeting.
  - l. Bruce and Jim DiPaola are in charge of the table we will setup at the Cincinnati convention.
  - m. Steve said that the Cincinnati(Division-7) has offered to sell us the used laptops that they will be using in May. We will need at least 4 but upwards of 7 or 8 in total.
  - n. The logo will read "The Bullet 2019," red on lemon, with one line out-lining it.
  - o. A discussion was led by Steve on the banquet and having a reception. The hotel gives us \$5 to spend for each room rented. We could have a president's reception for the MCR president and Peter Magoun, the next NMRA president. We would have to use the hotel's kitchen for the reception food. A cash bar was suggested. The banquet for the convention will cost \$40.
  - p. We need signs for the hotel rooms we are using. They could be either in some kind of frame by the door or on a stand. They would need our logo on them so other people in the hotel would know the room was part of our convention.
  - q. Lloyd stated that we will need 19 awards to give out. First place finishers would get a plaque. The plaques won't have the person's name on them. We should consider using ribbons for the 2nd and 3rd place awards to save money. It was suggested that people who don't get an award should get a certificate of appreciation for participating.
  - r. Mike showed a picture of an AC&Y double door parts box car that has not been modeled. He also showed a picture of an AC&Y gondola. Accurail has kits available that are much like these two cars and would be the most cost-effective way to have a convention car made.

## Proposed change to Division 1 Bylaws

In the last issue of the Peddler Freight, the complete Division 1 Bylaws were printed. To avoid any confusion just the proposed additions and deletions are below. These changes will be voted on at the January event. The entire bylaws are available on the Division 1 website.

### Section 3: Meetings

3.1 Meetings of Division 1 shall be held in the counties in its territory during the months of September, October, November, January, February, March, April, May and **June** unless a different meeting location is approved by a majority of the members attending the meeting at which such an alternate meeting place is proposed.

### Section 5: Elections / Appointments

5.1 Officers of Division 1, shall be NMRA members, elected bi-annually and shall serve for two **(2)** years. **Newly elected officers shall begin their terms on July 1<sup>st</sup> in the year they are elected.**

5.4 The Treasurer shall be an elected officer **and not subject to term limits.**

5.6 ~~All elected officers~~ **The Superintendent and Assistant Superintendent** may serve for a maximum of two **(2)** consecutive full terms in the same office. This does not prohibit any officer from standing for the same office in the future. **The Treasurer may serve for an unlimited number of consecutive terms.**

### ~~Section 7: Amendments~~ **Bylaws**

~~7.1 Amendments to these BYLAWS must have a majority vote of the members attending the meeting following that at which the amendment is proposed. Procedure of notification will be the same as outlined for special projects in Section 4.2 of these BYLAWS.~~

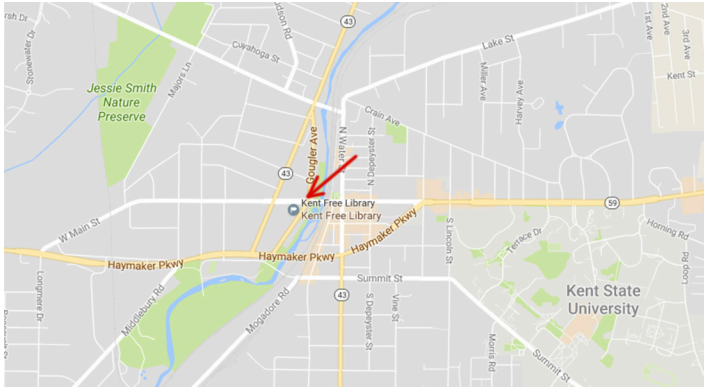
**7.1 In the event changes are proposed to the Bylaws the proposed changes shall be published in The Peddler Freight. At the next regular meeting the proposed changes will be presented for a vote. At least 75% of the members attending the meeting must approve the proposed changes.**

**7.2 The Superintendent shall be responsible for keeping track of the Bylaws of Division 1.**
